I expressly agree to waive the right to sue BNI for any reason whatsoever, now or in the future, that results from, or is a result of, my participation in the EVENT, for any reason, including negligence by BNI.

I further agree to indemnify and hold harmless BNI from any and all claims resulting from, or arising out of, my participation in the EVENT, including, but not limited to, claims relating to personal injury, financial loss and contracting Covid-19.

I ACKNOWLEDGE THAT I HAVE READ AND UNDERSTAND THIS WAIVER AND BY SIGNING IT I AGREE THAT IT IS MY INTENTION TO RELEASE BNI FROM ALL LIABILITY ARISING OUT OF OR RELATING TO MY PARTICIPATION IN THE EVENT.
